Welcome

The Groupe Consultatif's annual Colloquium will be held this year in Vienna, on 23 October, at the invitation of the Aktuarvereinigung Österreichs.

The theme of this year's Colloquium is **Pensions and security: risks in pension systems and how to secure them**. The past decade has brought broad recognition of the importance of pension systems to the economic stability of nations and the security of their ageing populations. As countries around the world grapple with the long-term affordability of their pensions systems, there are also growing demographic and economic pressures that are forcing both developing and developed countries to undertake urgent pension reforms. Most public pension schemes were not designed to deliver current benefit levels when confronted with today's major demographic and economic changes. Therefore, keeping existing systems afloat will require either cutting public spending on health and education, or cutting pensions drastically for the next generations of elderly. The experience with reforms over the past ten years has also shown that no one size fits all.

The Colloquium will review a number of the key issues which influence the risks and security of pension systems, from various perspectives. There will be speakers from the World Bank, the pensions industry, the actuarial profession and the European Commission, and we expect a number of lively presentations and discussions.

On behalf of Aktuarvereinigung Österreichs, I look forward to welcoming you to our historic and cultural capital city of Austria for what I am sure will be a stimulating Colloquium programme.

Vienna

Vienna (Wien) has a unique charm, vibrancy and flair. Its role as the seat of the Hapsburg Empire for centuries can be seen in the wealth of architecture and in the city's artistic and musical heritage. Many of the world's best-known composers, including Beethoven and Mozart, have lived and performed here.

Sightseeing opportunities abound. Wander along narrow, medieval alleyways or across imperial squares; view Schönbrunn Palace, the former summer seat and residence of the Hapsburgs, with its parks, palm house, butterfly house and world renowned Zoo; marvel at the Imperial Palace (Hofburg) and the majestic Ringstrasse boulevard. St. Stephan's Cathedral is one of the City's oldest buildings, combining, as a result of its lengthy construction time, a number of different architectural styles.

In addition to Vienna's baroque splendour, there are excellent examples of the art nouveau (Jugendstil) architecture that also flourished here. The collecting passion of art-loving rulers and monarchs has made Vienna a treasure house par excellence. The Museum of Fine Arts, for instance, is one of the world's largest and most distinguished museums, housing priceless works of art. Art accompanies you wherever you go in Vienna – even some of its underground stations are listed properties!

Vienna is renowned for its excellent coffee and cafés. Austrian coffee houses 'Kaffeehaus' are something of an institution as are its wine taverns 'Heurige'. Viennese cuisine is best known for its pastries, but it includes a wide range of other unique dishes from Wiener Schnitzel to Sacher-Torte.

Vienna International Airport is 18km southeast of central Vienna. There are frequent train and bus services into the city centre:
